Homeward Bound uses the best practice Housing First model to end homelessness. Housing First is a homeless assistance approach that prioritizes providing permanent housing to people experiencing homelessness. This approach is guided by the belief that people need basic necessities like food and a place to live before attending to other needs such as getting a job, budgeting, or attending to mental health and substance use issues.

Volunteering during Fiscal Year 2020-2021 included many challenges and triumphs. Renovation of AHOPE and the COVID-19 pandemic halted most of our volunteer opportunities. Volunteers who were able to work throughout the pandemic and the renovation project share that conditions were challenging. However, these conditions and sacrifices allowed Homeward Bound to receive a remodeled AHOPE with ample room for our clients, volunteers, and staff to gather. Stations like the mailroom, kitchen, and basement now have more storage options and space in general for volunteers and staff to address client needs.

The number of vulnerability assessments and diversions completed in FY 20-21 is lower than previous years due to limited capacity caused by the pandemic.

## **AHOPE Day Center Remodel**

Homeward Bound's remodeled AHOPE Day Center opened in February 2021. AHOPE, built in 1998 to serve 50 folks a day, grew to serving an average of 176 people every day in early 2020. It was in desperate need of repairs. Homeward Bound engaged architect Carlton Collins and contractor Beverly-Grant, Inc. to lead the facility's design and construction. Generous funders for the renovation include The Cannon Foundation, Buncombe County, Grace Covenant Presbyterian Church, DEPCOM Power, Patricia Simms, Rick and Lynne Noble, and a donor who anonymously contributed \$725,000 to the project.





### **PERMANENT SUPPORTIVE HOUSING**

"People don't realize that life can change as quickly as putting your shoes on." That's what Zach expressed when asked how he became homeless. Zach was involved in a horrific car accident. He sustained a traumatic brain injury and remained hospitalized for months in tremendous pain. Because Zach was disabled and couldn't work, he lost his job, his home, and soon he was living on the streets. Zach met case manager Alanna, and she moved him into the Woodfin, Homeward Bound's Permanent Supportive Housing apartments, where he is thriving in a community of survivors who were formerly homeless. He will receive case management and supportive services for as long as he needs them. Zach has taken up art and gardening, and is healing from the trauma of being homeless.


It is estimated the community annual cost per chronically homeless person is \$30,000 to \$50,000. By contrast, the annual cost to provide housing and case management per person is \$13,000.

### Housing is Healthcare

When people are homeless their health deteriorates. In their own home, people shift from survival mode to being more proactive about their wellness. They eat better, sleep better, and their health improves.

#### Dr. Brown's Housing is Heathcare Fund

Dr. Brown Crosby has been an advocate for marginalized members of the community for many years. Crosby was impressed with the work Homeward Bound is doing to end homelessness and made a \$250,000 gift to the organization. The funds support client utility payments, rental arrears, utility arrears, pest control services, prescriptions, keys, box fans and other miscellaneous expenses.

Homeward Bound purchased the Days Inn property on Tunnel Road. Renovations are projected to begin in March 2022, and will turn 127 hotel rooms into 85 efficiency apartments and offices for Homeward Bound administrative and program staff. The acquisition was made possible by funding from the City of Asheville and Buncombe County, Dogwood Health Trust, and an anonymous donor.

When the facility opens, extensive supportive services will be available including on site case management tailored to each resident's needs, 24/7 support staff, behavioral health services, social and educational activities, meals provided by community partners, job training, and a medical clinic.

### **RAPID REHOUSING**

Homeward Bound's Rapid Rehousing Program is designed to quickly house people facing homelessness.



Mae moved into to the Red Roof Inn when the pandemic hit and stayed there for four months. She kept to herself and mostly stayed in her room. She and her case manager, Flint, submitted applications to five or six different places before she got her current apartment. Mae hopes she never has to move again because her new place feels like home to her. She's enjoying having a place for all of her things, and is hoping to purchase items for donations that will benefit other folks who have or are experiencing homelessness.

### Preventing Homelessness

We served 12 civilian households and 20 veteran households in our Homeless Prevention Programs by providing financial support, budgeting and household maintenance training, and referrals to mental health support and other community resources.

### LANDLORD PARTNERSHIPS



Our landlord partners are critically important to Homeward Bound's mission of preventing and ending homelessness. In 2020/21, we ramped up the supportive services we offer to provide landlords support with tenant and property management.

Homeward Bound's landlord partner at Pisgah Knoll, LLC built a ramp for a client struggling to enter her home due to mobility issues. Because of this landlord's initiative, the tenant now feels safe in her long-term home.

In 20/21, we coordinated 75 leases with private landlords and partnered with more than 50 to provide stable housing to those in our community.

### **HELPING UNHOUSED VETERANS**

Our Supportive Services for Veteran Families (SSVF) program provides rapid rehousing services (rental assistance and housing case management that ranges from six months to two years) to veteran households. SSVF also provides prevention services with rental assistance and housing case management to veteran households to prevent eviction. The program incorporated a healthcare navigator into the program this year to specifically work with veterans in navigating their healthcare needs and benefits. This program works in close partnership with the local Veterans Administration and other community service providers.

### **VETERAN SHELTER**

Our Supportive Services for Veteran Families emergency shelters, which took place in various motels around Asheville, started in March 2020 and served 118 veteran households. 74 of them were moved to permanent housing. In 20/21, Homeward Bound's various veteran shelters dramatically decreased the spread of COVID throughtout local homeless communities.

SSVF Team

Many of these veterans and their families would have been living unsheltered without this resource during the pandemic, making it difficult for us to find them, meet with them, and complete paperwork with them to begin the process towards housing. Having various motels for sheltering clients during COVID allowed us to keep veterans safe while working to end their homelessness more quickly.


David, a veteran who experienced homelessness for 20 years, was in Homeward Bound's Veteran Shelter Program for five months before he was moved into his own home right as the Coronavirus began to spread.

"Even though I haven't had alcohol or drug issues, there was always something holding me back. To this day, I can't put my finger on it. Something in my head, my thoughts, perhaps the way I viewed the world. But having a home is the solution." – David

### SHELTERING DURING THE PANDEMIC

From April 2020 to June 2021, Homeward Bound sheltered 166 individuals (beginning at Harrah's Cherokee Center and then transitioning to the Red Roof Inn in May of 2020) and moved 42 of these people into permanent housing. Only one client contracted COVID-19 during that time.





#### When Dwight was 17, his mother took his father's life by shooting him. Because of this trauma, Dwight moved around a lot and lived outside for more than six years. He eventually came to AHOPE where the staff enrolled him at the Red Roof Inn to shelter during the pandemic. That's when Dwight met Homeward Bound Case Manager Elizabeth Bowers, who helped him move into a home in December.

### WARMING CENTERS PROVIDED RELIEF

It was a bitter winter for people living unhoused. When you don't have a home, your life often revolves around finding places to be during the day-to come in from the cold, to sit and rest, and to use the restroom. Places such as libraries, grocery stores, and shops couldn't allow people to assemble because of COVID-19. Our own AHOPE day center was being renovated, which limited the number of poeple who could come inside.

Jubilee! Community Church and Central United Methodist Church ran warming centers where people experiencing homelessness could warm up, have a snack, a cup of coffee and socially distanced fellowship.



### **OUTREACH**

The Outreach Team is focused on reaching the most vulnerable homeless individuals living on the streets of our community to connect them with permanent supportive housing, healthcare, disability income, and community mental health services. We meet people where they are: in the woods, under bridges, and on the street.

### **REACH - Real Estate Agents Combatting Homelessness**

Since the inception of REACH three years ago, 76 Realtors and allied professionals, along with 159 REACH supporters, have raised close to \$156,000. REACH members have been instrumental in providing 155 comfortably furnished homes where residents have achieved housing stability.

Brokers giving a portion of each commission receive commemorative cards to use at closing, recognizing that a gift has been given in honor of the buyer.

## THIRD ANNUAL OPEN YOUR HEART FOR WOMEN AND HOMELESSENSS

Nearly 60% of women experiencing homelessness cite domestic violence as the direct cause of their homelessness, and we know that number is low because intimate partner violence is not always reported.

On February 12, Homeward Bound hosted its *Third Annual Valentine's Open Your Heart for Women and Homelessness Lunch and Learn* exploring the intersection between domestic violence and homelessness. A panel of experts included Helpmate and Homeward Bound staff.

Panel of Experts: Homeward Bound Program Administrators Alanna Kinsella, Liz Sanford, and Nicole Brown were joined by Helpmate Counselor and Case Manager Dori English Bronya finally escaped the cruelty and violence of the man she was involved with for more than a decade. She suffered constant beatings and verbal abuse, and her self-esteem was destroyed. Bronya's life was never easy but being homeless was the worst. It was lonely and scary. When she lived outside, she had to watch out for copperheads and other wild animals. Coyotes came so close to her tent that she could hear them breathe. Listening to the eerie growl of bobcats was terrifying. Homeward Bound moved Bronya into housing in October and she graduated the program in March 2021.

Women make up 25% of the homeless population in Asheville and Buncombe County. 23% are chronically homeless.




