THE CENTER ACCEPTS DONATIONS OF FURNITURE, HOUSEHOLD GOODS, AND OTHER ITEMS NECESSARY FOR SETTING UP A NEW HOME. THESE DONATED FURNISHINGS ARE PHYSICALLY MOVED INTO THE NEW HOMES OF INDIVIDUALS AND FAMILIES WHO HAVE SECURED HOUSING. THE WELCOME HOME DONATION CENTER, IN KEEPING WITH HOMEWARD BOUND'S LOWBARRIER SERVICES APPROACH, HELPS MAKE THE TRANSITION FROM HOMELESSNESS TO STABLE HOUSING LESS STRESSFUL AND MORE MANAGEABLE FOR OUR NEIGHBORS IN NEED. OUR WELCOME HOME DONATION CENTER TRANSFORMED 122 HOUSING UNITS INTO FULLY FURNISHED HOMES BY DELIVERING \$143,656 WORTH OF COMMUNITY DONATIONS.
